7pm Wednesdays to **9am** Thursdays

7pm Thursdays to **9am** Fridays

Closed: Fridays, Saturdays, Sundays

Other Restrictions: All marine waters south of a line running directly northeast from the northern most end of the railroad trestle nearest the 4th Avenue Bridge to northern end corner of the Bayview Thriftway board walk are CLOSED. Northern end corner of Bayview board walk is defined as approximately 360 ft of board walk from the 4th Avenue Bridge. **Set nets must be 150 feet apart; no nets may be tied together. No gillnet shall extend more than one-third (1/3) of the way across any boat channel, inlet cove, or creek mouth.** No nets may be attached to the Yacht Club facility or Bay View dock. A channel must be maintained to all moorage docks located in Budd Inlet. Set nets shall be located according to the normal fishing regulations.
