Policy:

Squaxin Island Tribal Gaming Agency will offer a self-exclusion process knowing that compulsive gambling habits impacts individuals and families. The program will allow individuals to self-exclude themselves if they recognize a compulsive gambling habit. The exclusion will be an agreement between the individual and the Tribe that we do not want you gambling here based on your acknowledgment that you may have a compulsion to gamble, therefore restricting you from all gaming venues of the Tribe.

The agreement requires that you do not enter the property of the Little Creek Casino Resort. Failure to comply will result in **permanent barring** for criminal trespass and any winnings resulting from your failure to comply will be forfeited. You may also be subjected to arrest and have your vehicle towed.

A self-exclusion lasts for the time period selected on the Self-Exclusion form.

Process:

- Notify Security you wish to self-exclude yourself.
- Security will inform Tribal Gaming.
- An Agent will verify your identity.
- You must sign the Self-Exclusion Form.
- You will be escorted to the doors of the facility and asked to leave.
- You will be excluded from the property until your time period selected has lapsed. There is no appeal process.

Violation of your Self-Exclusion will result in your permanent barring for criminal trespassing. You may be arrested and be denied of any future request for reinstatement.



Lifting your self-exclusion:

You are excluded for the time frame you requested when you initially requested the self-exclusion (There is no exceptions). You may request permission to attend special non-gaming events on a case by case basis. You may call the Tribal Gaming Offices to obtain this procedure but you should do it 14 days before needed. Your request is subject to a number of known factors and may not be approved.
