THE GRANTOR, SHELTON PUBLIC SCHOOL DISTRICT NO. 309, a municipal corporation, for and in consideration of THIRTY THOUSAND and no/100 (\$30,000.00) DOLLARS, conveys and quit claims to THE UNITED STATES OF AMERICA IN TRUST FOR THE SQUAXIN ISLAND TRIBE of the Squaxin Island Indian Reservation, Washington, the following describea real estate, situated in the County of Mason, State of Washington, including any after-acquired title:

That portion of the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 18, Township 19 North, Range 3 West, Willamette Meridian, described as follows:

Beginning at the Southeast corner of said SW $\frac{1}{4}$  of the SE $\frac{1}{4}$ ; thence North along the East line of said subdivision 560 feet; thence West parallel with the South line of said subdivision 224 feet, more or less, to the Southerly right of way line of Primary State Highway No. 9-D; thence Southwesterly along said right of way line 158 feet; thence South parallel with the East line of said subdivision 505 feet, more or less, to the South line of said subdivision; thence East along said South line 382 feet, more or less, to the Point of Beginning.

This conveyance is made pursuant to the Act of June 18, 1934 (48 Stat. 984).
