RESOLUTION NO. 21-10

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**

WHEREAS, the U.S. Department of Justice has announced the availability of new funding through the FY 2021 Coordinated Tribal Assistance Solicitation that includes support for a variety of justice- and service-related program areas; **and**

WHEREAS, the Squaxin Island Tribe administers a variety of youth engagement services and a Teen Development Program through its Education Department (Tu Ha' Buts Learning Center); **and**

WHEREAS, the Squaxin Island Tribe acknowledges the need to support comprehensive, collaborative and coordinated service-based programming that promotes individual and community wellness, especially programs that support positive youth development;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Education Department (Tu Ha' Buts Learning Center) to prepare, submit, negotiate, execute, and administer with the Department of Justice a five-year project for up to \$500,000 through the Coordinated Tribal Assistance Solicitation under Purpose Area #9: Tribal Youth Program (Office of Juvenile Justice and Delinquency Prevention).

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chair, Tribal Administrator or the Director of Operations to be the Tribe's signatories and representatives in all future matters requiring Tribal authorization on this particular project; **and**

THEREFORE BE IT FINALLY RESOLVED, that these authorities shall be for the duration of the project.

CERTIFICATION
