RESOLUTION NO. 22-14

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Tribe's Planning and Community Development Program has negotiated the terms of a Tribal Transportation Program Agreement ("Agreement") with the United States Department of the Interior; and

WHEREAS, the Agreement transfers to the Tribe all those functions and duties of the Secretary of the Interior related to the Tribal Transportation Program that may lawfully be transferred to the Tribe and provides funding to carry out those functions and duties; and

WHEREAS, the Tribe has for many years administered similar agreements and Tribal Council believes it in the best interest of the Tribe to continue fulfilling such functions and duties as a matter of self-governance;

NOW THEREFORE BE IT RESOLVED, that Tribal Council approves the attached Tribal Transportation Program Agreement and authorizes and directs its Chair to sign the same.

CERTIFICATION

The Squaxin Island Tribal Council hereby certifies that the foregoing Resolution was adopted at the special meeting of the Squaxin Island Tribal Council, held on this 10th day of March, 2022, at which time a quorum was present and was passed by a vote of 6 for and 0 against, with 0 abstentions.
