



# SQUAXIN ISLAND TRIBE

## RESOLUTION NO. 17-08

of the

### SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

**WHEREAS**, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; and

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

**WHEREAS**, the Bureau of Indian Affairs maintains the official Road and Bridge Inventory for the Tribal Transportation Program (TTP) Roadway Inventory Field Data System (RIFDS); and

**WHEREAS**, the Squaxin Island Tribe has completed a comprehensive 2017 Long Range Transportation Plan (LRTP) Addendum and National Tribal Transportation Facility Inventory (NTTFI) update to update and support the 2015 LRTP, they are designed to support the Tribe's future development plan, new roads, trails, parking areas, and other transportation facilities that will be required to support the expanding transportation network; and

**WHEREAS**, the transportation facilities recommended for addition, as well as revisions to existing facilities, and a few deletions of antiquated routes that no longer represent our transportation network and Tribe's TTP Inventory are shown on Attachment A – Recommended Inventory Table, and are reflected in the attached 2017 LRTP Addendum; and,

**WHEREAS**, the 2017 LRTP Addendum was developed to support the NTTFI Update and provide insight into the future development plans for the Tribe's transportation system;

**NOW THEREFORE BE IT RESOLVED** that the Squaxin Island Tribal Council requests that the route revision additions and deletions as listed in the attached table be accepted to the TTP Inventory as they are entered into the RIFDS program with all required supporting attachments.

**NOW THEREFORE BE IT ALSO RESOLVED** that the Squaxin Island Tribal Council approves the updated 2017 National Tribal Transportation Facility Inventory Update and Long Range Transportation Plan Addendum.
