RESOLUTION NO. 22-70

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**

WHEREAS, the Washington State Recreation and Conversation Office has announced the availability of funding for outdoor education for youth through the No Child Left Inside Grant Program; **and**

WHEREAS, the Squaxin Island Tribe operates an Education Department which provides comprehensive wrap-around services to community youth at the Tu Ha' Buts Learning Center; **and**

WHEREAS, providing education services, cultural immersion, social and emotional development support and other services to community youth is a priority for the Squaxin Island Tribe;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Education Department to prepare, submit, negotiate, execute, and administer with the Washington State Recreation and Conversation Office a grant proposal and agreement, and any amendments thereto, for the No Child Left Inside Grant Program for the period of July 1, 2023 to June 30, 2025.

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chair, Tribal Administrator or the Director of Operations to be the Tribe's signatories and representatives in all future matters requiring Tribal authorization on this particular project; **and**

THEREFORE BE IT FINALLY RESOLVED, that these authorities shall be for the duration of the project.
