RESOLUTION NO. 12- 11

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**

WHEREAS, the Squaxin Island Tribe has been advised of the availability of funding for a new five year funding cycle through the United States Department of Health and Human Services, Centers for Disease Control and Prevention, Cancer Prevention and Control Programs for State, Territorial and Tribal Organizations, CFDA #93.919, Funding Opportunity Number CDC-RFA-SP12-1205; **and**

WHEREAS, the Squaxin Island Tribe is a member of the South Puget Intertribal Planning Agency (SPIPA), through which body it presently operates a Breast and Cervical Cancer Early Detection Program (BCCEDP) to provide cancer screening and treatment referral services for women, and to promote awareness of the availability and importance of screening services; **and**

WHEREAS, SPIPA, in consultation with the Squaxin Island Tribe, has determined that it is in the best interest of the members of the Tribal communities to continue this funding and implement new projects related to breast and cervical cancer prevention and early

detection for the period of June 30, 2012 through June 29, 2013 renewable each year for five years; **and**

WHEREAS, SPIPA will submit an application for funding under the above referenced funding opportunity for an amount not to exceed \$635,121 in federal funds which will be matched by SPIPA and the participating Tribes with in-kind services or non-federal funds; **and**

WHEREAS, the Squaxin Island Tribe will complete a Memorandum of Agreement with SPIPA prior to the implementation of the program;


NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby authorize SPIPA to submit a proposal to the Centers for Disease Control and Prevention for an amount not to exceed \$635,121 on behalf of SPIPA and the Squaxin Island Tribe for the period of June 30, 2012 to June 29, 2013.

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chair, Tribal Administrator or Director of Operations to be the Tribe's signatory and representative in all future matters requiring Tribal authorization on this particular project; **and**


THEREFORE BE IT FINALLY RESOLVED, that these authorities shall be for the duration of the project.
