



# SQUAXIN ISLAND TRIBE

## RESOLUTION NO. 13-90

Of the

### SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965;

**WHEREAS**, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe;

**WHEREAS**, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government;

**WHEREAS**, the Squaxin Island Tribal Council is empowered to acquire, manage, lease, or use Tribal real property under its Constitution, Article III, Section 1(b), and its inherent authority;

**WHEREAS**, it is a goal of the Squaxin Island Tribe to re-acquire the entire Squaxin Island, including land, tidelands, and mineral rights;

**WHEREAS**, the Bureau of Indian Affairs has completed an appraisal of all trust lands on the Squaxin Island, in order to determine fair market value;

**WHEREAS**, funding is available through the U.S. Department of Interior, Bureau of Indian Affairs for buy-back of fractionated trust interests of Indian lands;

**WHEREAS**, the Squaxin Island Tribal Council has determined a priority for acquisition of fractionated interests on the Squaxin Island; now


**THEREFORE BE IT RESOLVED**, that the Squaxin Island Tribal Council agrees to purchase fractionated trust land ownership interests on the Squaxin Island;

**BE IT FURTHER RESOLVED**, that the Squaxin Island Tribal Council has determined that the priority for purchasing the interests shall be as follows:

1. Allotment 20 (BIA Tract 121-20)
2. Allotment 16 (BIA Tract 121-16)
3. Allotment 17 (BIA Tract 121-17)
4. Allotment 18 (BIA Tract 121-18)
5. Allotment 13 (BIA Tract 121-13)


### CERTIFICATION


