### RESOLUTION NO. 14-13

#### of the

#### SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

**WHEREAS**, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the State Department of Natural Resources has requested the Tribe's participation and assistance in the design and construction of historically authentic canoes to exhibit the presence, use and occupancy of Squaxin Island peoples; and

WHEREAS, the Squaxin Island Tribal Council has reviewed the Scope of Work for Design and Construction documents for Native American Canoes at Woodard Bay NRCA for Squaxin Island Tribe ("Scope of Work"); and

**WHEREAS**, Barker Landscape Architects has agreed to work with the Squaxin Island Tribe to oversee construction of the Canoes.

**NOW THEREFORE BE IT RESOLVED,** that the Squaxin Island Tribal Council approves the Scope of Work (attached).

## Scope of Work for Design and Construction Documents for Native American Canoes at Woodard Bay NRCA for Squaxin Tribe

Outline of Work Tasks Date: 12/12/13

1. Research historical records of Squaxin and south Puget Sound inland waterway canoes, and carved shotcrete petroglyph seats, particularly those that may have been used in Henderson Inlet and environs (16 hours)

2. Closely coordinate with DNR Project Manager, Squaxin Cultural and Legal Staff throughout project as needed. (12 hours)

3. Measure and create "as built" dimensions, and photograph for textures, colors and details (thwarts, bow, stern, height, width, length, girth, etc.) (30 hours)

4. Based on Squaxin Tribal Resources, determine best representative contents of canoes and accurate details for carved shotcrete petroglyph seats. This will likely include paddles, baskets, fish and/or shellfish, or other likely contents that would be found in canoes left on shore. Also provide details for carved shotcrete petroglyph seats. (16 hours)

5. Develop plans and specifications that identify materials, textures, colors, size, shape and anchoring methods for each of 3 vessels, and carved shotcrete petroglyph seats (40 hours)

6 . Determine best contracting and delivery method to translate documented designs into artistic shotcrete with submittals, mock ups, samples and quality control to ensure best product. (8 hours)

7. Develop bidding documents, contact artistic shotcrete contractors, obtain bids for presentation to DNR and to Squaxin Tribe staff, recommend award and develop construction contract in appropriate formats. (24 hours)

8. Work with DNR and Squaxin staff to oversee construction at Woodard Bay NRCA per plans approved by DNR. Provide weekly construction compliance and minutes of each meeting. Review submittals, samples, pay applications and any proposed changes. At completion, develop punchlist and record drawings. (48 hours)
