

# SQUAXIN ISLAND TRIBE

## RESOLUTION NO. 00-84 OF THE SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**,

**WHEREAS**, under the Constitution and the Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**,

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**,


**WHEREAS**, the Squaxin Island Tribal Council delegated to the Squaxin Island Tribal Housing and Utilities Commission the authority to create policies governing the Tribal Housing Program and the tribal Utilities Program and to adjudicate interpretation of these policies; **and**,


**WHEREAS**, the Squaxin Island Tribal Housing and Utilities Commission have approved "Reservation-Wide Garbage" Policy by Resolution; **and**,


**NOW THEREFORE BE IT RESOLVED**, that the **Squaxin Island Tribal Council** does hereby approve "Reservation-Wide Garbage" Policy of the Squaxin Island Tribal Housing and Utilities Commission Policies.

## **GARBAGE POLICY**

Garbage service will begin on Monday, December 4, 2000. Every housing unit on Squaxin Island Reservation will have garbage collection service provided by Mason County Garbage Service.

The bill for garbage service will be based on the number of individuals in your home. Family size will be adjusted annually following your regularly scheduled housing inspection. The Department of Community Development (DCD) may adjust the garbage rate annually, based on actual garbage collection costs or increased administrative costs.

### **Garbage Rates**

<b>Family Size</b>	<b>Rate</b>
1	\$ 6.50
2	\$ 9.50
3-4	\$13.00
5+	\$17.00

On a one time only basis new garbage collection customers will receive a 32-gallon garbage can, current garbage collection customers who have cans larger than 32 gallons will also receive a new garbage can. After this initial distribution of containers, each household will be responsible for providing their own garbage containers.

There is no limit to the number of cans you put out each week. Garbage must be brought down to the curb early every Monday morning. Do not overfill the cans, if you have more garbage than can fit into the can, use another can or garbage bag. Garbage cans cannot weight over 65 pounds. Appliances and large furniture items will not be collected during the weekly garbage collection.

1. Bulky garbage that will not fit into the garbage can should be put into tied plastic bags.
2. Appliances, large furniture, and other large items will not be collected.
3. Loose garbage (not in a can or bag) will not be collected.
4. The garbage collector may refuse service when an animal feared or considered vicious is loose.
5. Neither the Tribe nor the garbage collector assumes responsibility for articles left in or near cans or bags.

6. Weather conditions may prevent regular garbage collection and garbage will be collected the following day.
7. Garbage is not collected the following holidays:
  - New Year's Day
  - Memorial Day
  - Independence Day
  - Labor Day
  - Thanksgiving Day
  - Christmas Day

Garbage will be collected the next business day.
