RESOLUTION NO. 02-86

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Office of Community Services in Family Support Administration has announced the availability of funds for grants under the Community Services Block Grant (CSBG) program for the purpose of supporting community services; and

WHEREAS, the Squaxin Island Tribe is a member of a Tribal Consortium planning agency, the South Puget Intertribal Planning Agency (SPIPA), and SPIPA has since 1981 operated a CSBG on behalf of the member tribes; **and**

WHEREAS, the Squaxin Island Tribal Council has been advised that additional and continued funding is needed for Elders meals and for a Senior Coordinator on the Squaxin Island Reservation.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby authorize development and submission of a Fiscal Year 2003 grant proposal on its behalf by SPIPA for continuation of the current CSBG Program funding; and
