RESOLUTION NO. 03 - 35

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

WHEREAS, the Squaxin Island Tribal council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**

WHEREAS, on June 10th, 2000 the General Body voted to amend the Constitution and By-laws of the Squaxin Island Tribe; **and**

WHEREAS, the proposed amendments to the Constitution were put before the registered voters of Squaxin Island Tribe on October 20, 2000; and the amendments were approved by a majority of the qualified voters; **and**

WHEREAS, the amendments to the Squaxin Island Tribe Constitution were approved by the Secretary of the Interior; **and**

WHEREAS, amendment one changed the Annual Meeting to the spring of each year rather than January; and

WHEREAS, the annual General Body Meeting was held on May 3, 2003; and

WHEREAS, elections were held for the two positions on the Squaxin Island Tribal Council with terms which had expired.

NOW THEREFORE BE IT RESOLVED, out of 481 eligible voters of the General Body, more than 60 percent of a quorum was present by third quorum call and elected the following persons to serve on the Tribal Council:

WHEREAS, elections were held for the two positions on the Squaxin Island Tribal Council with terms which had expired.
