RESOLUTION NO. 05-117

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Tribal Council has determined that it is necessary and desirable to expand the existing video surveillance system at the Little Creek Casino Resort; and

WHEREAS, the Director of the Squaxin Island Gaming Commission has presented a proposed contract with Southwest Surveillance Systems, a Nevada corporation, to provide certain equipment and installation services necessary to facilitate such expansion; and

WHEREAS, the Tribal Council has determined that the proposed contract with Southwest Surveillance Systems attached hereto is in order;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby agrees to enter into the attached (the "Contract") with Southwest Surveillance Systems, a Nevada corporation, to expand the existing video surveillance system by providing certain equipment and installation services.


NOW THEREFORE BE IT FURTHER RESOLVED, the Tribal Council specifically limits its waiver of sovereign immunity for the purposes of this Contract as follows:

Nothing in the contract shall be deemed to waive the sovereign immunity of the Squaxin Island Tribe, its agents or enterprises, except to the extent of the agreed contract price in the amount of \$647,997.00. The source of funds for any remedy shall be limited to the net revenues of the Squaxin Island Gaming Commission, a wholly-owned subsidiary of the Squaxin Island Tribe.


NOW THEREFORE BE IT FINALLY RESOLVED, that the Tribal Council hereby authorizes Council Chairman, the Executive Director, or the Director of the Squaxin Island Gaming Commission to execute the contract, negotiate and enter into any non-material modifications thereof, and to do any and all accounts necessary to effect execution of the Contract.



FOR GOODS AND/OR SERVICES

This Contract is entered into on the Squaxin Island Reservation this 28th day of November, 2005, between the SQUAXIN ISLAND TRIBE, a federally-recognized Indian Tribe, located on the Squaxin Island Reservation at Shelton, Washington, hereafter referred to as "SIT", and SOUTHWEST SURVEILLANCE SYSTEMS, a Nevada corporation with a principal place of business at 6265 S. Valley View Dr., Las Vegas, NV 89118, hereafter referred to as the "Contractor". This Contract consists of this written agreement and "Exhibit A" attached hereto and incorporated herein by reference, (collectively, the "Contract Documents").

1. Description of Goods and/or Services: Contractor shall provide the goods and/or services described in the attached Exhibit A.
2. Contract Price: SIT agrees to pay Contractor for the goods and/or services the price described in Exhibit A. Payment of this amount is subject to additions or deductions in accordance with the provisions of this Contract. Payment shall be as set out in Section 3 of this Contract.
3. Method of Payment:
 - 3.1. SIT shall make payments to Contractor according to the schedule included in Exhibit A.
 - 3.2. Any payment to be made under this Contract may be withheld if:
 - 3.2.1. The goods and/or services are found to be defective and the defect is not remedied;
 - 3.2.2. In the opinion of SIT, Contractor's performance is not consistent with the terms of this Contract; or
 - 3.2.3. Contractor fails to comply with any applicable law or regulation, or to pay any applicable tax, fee or license.
4. Claims:
 - 4.1. By making payment, SIT waives all claims except those arising out of:
 - 4.1.1. Faulty goods and/or services appearing after delivery or completion;
 - 4.1.2. Goods or services that do not comply with the Contract Documents;
 - 4.1.3. Outstanding claims of liens;
 - 4.1.4. Failure of Contractor to comply with any special guarantees or warranties required by the Contract Documents.

Upon written notice from SIT of any claims pursuant to this subsection 4.1, Contractor shall have fifteen days to cure the defect or other problem. If

Contractor fails to timely cure the defect or other problem, Contractor shall promptly return all payments received from SIT.

- 4.2. Contractor, by accepting payment, waives all claims against SIT as to those goods and/or services except those that Contractor has previously made in writing, and which remain unsettled at the time of acceptance.
5. Starting and Completion Dates: Contractor shall begin installation work pursuant to this Contract no later than January 3, 2006, and shall complete work pursuant to this Contract no later than March 31, 2006.
6. Default and Termination:
 - 6.1. This Contract may be terminated by either party without prejudice to any other remedy that the non-defaulting party may have if the other party defaults in performance of any provision of this Contract. The non-defaulting party shall give the defaulting party ten (10) days' written notice of the non-defaulting party's intention to terminate this Contract, within which time the defaulting party may cure the default condition to the satisfaction of the non-defaulting party. Should the defaulting party be Contractor, SIT may, pursuant to Section 3 of this Contract, withhold any portion of the Contract Price still owing at the time of the default.
 - 6.2. SIT may also terminate this Contract for its convenience without cause. Should SIT elect to terminate under this subsection 6.2, SIT shall give the Contractor written notice of the termination, which shall be effective immediately upon receipt, or three days after mailing, first-class, postage prepaid, whichever comes first, unless a later termination date is given. SIT shall pay for all goods and /or services properly provided up to the effective date of the termination. Contractor shall have no additional rights as against SIT except for the payment provided under this subsection 6.2.
7. Contract Officer:
 - 7.1. Desmond Smith is SIT's "Contract Officer" for the purpose of this Contract and shall provide general administration of the Contract as SIT's representative.
 - 7.2. Charles Wilkins is Contractor's representative for the purpose of this Contract and shall be responsible for the performance of this Contract, and shall have signature authority for the Contractor for all matters related to this Contract.
8. Responsibilities of Contractor: Contractor's duties and rights in connection with the project herein are as follows:
 - 8.1. Payment of Taxes, Procurement of Licenses and Permits: Contractor shall pay any applicable tribal, federal, state, and local taxes required by law in connection

with its performance under this Contract and shall secure all necessary licenses and permits, paying the fees therefore.

- 8.2. Compliance with Laws and Regulations: Contractor shall comply with all applicable laws and ordinances, and rules, regulations, or orders of all public authorities relating to the performance of this Contract. Contractor represents that it is duly licensed under the laws of the State of Washington and the SIT. If any of the Contract Documents are at variance therewith, Contractor's representative shall notify SIT's Contract Officer promptly upon discovery of such variance.
- 8.3. Responsibility for Negligence of Employees and Subcontractors: Contractor assumes full responsibility for acts, negligence or omissions of all of its employees under this Contract, for those of its subcontractors and their employees, and for those of all other persons doing work under contract with Contractor.
- 8.4. Warranty of Fitness of Goods and/or Services: Contractor represents and warrants to SIT that goods and/or services provided under this Contract will be of good quality, free of defects, consistent with performance representations made, and in conformity with the Contract Documents. It is understood between the parties hereto that all goods and/or services that are not so in conformity are defective. The warranty under this subsection 8.4 shall be effective for period of one year from the date SIT provides written approval that the project has been completed (the "Warranty Period"). Extended warranties and/or maintenance agreements are available at additional cost.
 - 8.4.1. On-Site Warranty: During the Warranty Period, any required services will be performed by Contractor on site of the equipment within a period of 72 hours after a system failure is reported on the matrix or matrix components. In addition, Contractor will perform four scheduled maintenance visits (one every 3 months) during the Warranty Period to provide preventative maintenance services.
 - 8.4.2. Walk-In Warranty: During the Warranty Period, a "walk-in" warranty, also known as a "mail-in" warranty, applies to all components that are not necessary for the full operation of the main system, for example, the back up Central Processing Unit or CM9760-MDA. Such warranty will be performed on an advance replacement basis, wherein the original part is brought to or mailed to the manufacturer's repair facility.
 - 8.4.3. Manufacturer Warranty: Notwithstanding the Warranty Period identified in this subsection 8.4, manufacturer's warranties shall be passed through to SIT as some manufacturer's warranties exceed one year in duration.
- 8.5. Indemnity and Hold Harmless Agreement: Contractor agrees to indemnify and hold harmless SIT and its officers, agents and employees from and against all claims, damages, losses, and expenses related to or arising from Contractor's

goods and/or services as set out in this Contract. Such expenses include reasonable attorneys' fees if it is necessary for SIT to commence or defend an action arising out of or associated in any way with Contractor's performance of this Contract. Such claims include, but are not limited to, claims for bodily injury, illness or death, property damage (including loss of use, or other damage) which are caused in whole or in part by Contractor's negligent act or omission, or that of Contractor's subcontractor, or that of anyone employed by either of them or for whose acts Contractor or Contractor's subcontractor may be liable.

- 8.6. Insurance: Contractor represents that it has, and will continue to have until the end of the Warranty Period, liability insurance coverage in the amount of \$2,000,000.00. A copy of Contractor's standard liability insurance certificate with applicable coverage limits has been provided to SIT. No performance or payment bonds are included.
9. Jurisdiction and Venue; Applicable Law; Sovereign Immunity:
 - 9.1. Contractor and SIT agree that the sole and exclusive jurisdiction over any disputes arising out of this Contract shall be in the Squaxin Island Tribal Court.
 - 9.2. Any dispute shall be determined under the laws of the SIT.
 - 9.3. Nothing herein shall be deemed to waive the sovereign-immunity of the SIT, its agents or enterprises, except to the extent of the agreed Contract Price in Section 2. The source of funds for any remedy shall be limited to the net revenues of the Squaxin Island Gaming Commission, a wholly-owned subsidiary of the SIT.
10. Independent Contractor: It is understood that the Contractor is operating as an independent contractor, and as such shall comply with all applicable laws and regulations and shall pay all applicable taxes and other assessments and hold SIT harmless from the consequences of any act or omission of whatever kind or nature of Contractor or its employees or agents of whatever kind. Contractor shall not have any right as an employee of SIT, and no employee-employer relationship is established by this Contract. Further, the Contractor is responsible for reporting this income to the applicable federal and/or state agencies. The Contractor is responsible for all taxes associated with this income. Contractor's Federal tax identification number is 88-0513980.
11. Records: Contractor will maintain adequate financial records, in accordance with generally accepted accounting practices, such that the Contractor can clearly and easily identify all claimed costs and expenses and the relatedness of those costs and expenses to this Contract.

12. Certification of Non-Segregated Facilities:

12.1. By signing this Contract, Contractor certifies that it does not maintain or provide for its employees any segregated facilities at any of Contractor's establishments, and that Contractor's employees are not permitted to perform their services at any location, under this Contract, where segregated facilities are maintained.

12.2. Contractor agrees that failure to abide by this certification is a breach of this Contract.

13. Non-Discrimination: Title VI of the Civil Rights Act of 1964, (Public Law 88-352; 42 USC 200d-1) provides that no person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.

14. Entire Agreement; Amendments: This Contract contains the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, oral or written, between the parties hereto with respect to the subject matter hereof.


15. Severability: If any part of this Contract is held unenforceable, the rest of this Contract will continue in effect.

16. No Partnership: This Contract does not create a partnership relationship. Contractor does not have authority to enter into contracts on SIT's behalf.

17. Assignment: Contractor may not assign or subcontract any rights or obligations under this Contract without SIT's prior written approval.

EXHIBIT A

DESCRIPTION OF GOODS AND/OR SERVICES
AND PRICE

Southwest Surveillance Systems Scope of Work for Expansion of CM9770 Cross Point Matrix Switch and Installation of Endura Network Video Recording for Squaxin Island Tribe.

1. General.

1.1. Work Schedule: This Contract is based on a standard 40-hour work week. Daily work schedules shall be planned in accordance with the general construction schedule. No overtime or shift work has been included in this Contract.

1.2. Installation: The video surveillance systems will be installed in a neat and workmanlike manner in accordance with industry standards. All cabling outside the surveillance room will be plenum-rated. All cabling will be labeled and neatly bundled. It is assumed that cable tray will be provided by the electrical contractor for cable management. Contractor will provide for individual cable management from the cable tray to the final camera location. The installation shall conform to all requirements of the latest version of NFPA 72, the National Electric Code. All equipment shall be UA labeled.

1.3. Purchase Price and Payment Schedule: SIT agrees to pay Contractor for the goods and/or services described in the Contract Documents as follows:

1.3.1. All charge orders will be invoiced as completed and added to process billings.

1.3.2. Payment terms are net 15 days from date of invoice.

1.3.3. "Project Completion" means the equipment is fully installed, tested and performance ready.

1.3.4. Notwithstanding the foregoing payment schedule, the final payment in the amount of \$32,399.85 shall not be due until Contractor has complied with the "System Documentation" provisions of subsection 1.6 of this Exhibit A.

1.3.5. The total amount in the foregoing payment schedule is for goods and/or services as described in the Contract Documents. Any other goods and/or

services or changes in the scope of work described herein will be addressed in separate quotes or reflected on change orders.

- 1.4. Critical Spares: Contractor has developed in conjunction with SIT, a list of critical spare equipment to be maintained on site for emergency service needs. The list of critical equipment has been developed and priced based on the final system design. Pricing for critical spare equipment is not included in the Purchase Price identified in Section 1.3 of this Exhibit A and will be invoiced separately on terms agreed to by the parties in the List of Critical Spare Equipment attached hereto and incorporated herein by reference.
- 1.5. Training: Contractor will provide necessary training to those individuals specified by SIT, which shall consist of technical training in the function, programming and maintenance of the system equipment. Additionally, operator training in the use of the system will be provided under the direction of factory or factory-trained personnel. Contractor will coordinate available training classes from the manufacturer for SIT's benefit. Such additional factory classes shall be provided at no additional cost; however, SIT will be responsible for travel, housing and meal costs for its personnel. Training will take place on site for surveillance operators and at the Pelco training facility in Fresno, California for technicians. The training will be provided as needed for a period of two (2) days. Training times and locations shall be determined at the Pre-Construction Conference. SIT technical training will include training in the use of the Operations & Maintenance Manuals identified in subsection 1.6 of this Exhibit A.
- 1.6. System Documentation: Complete system documentation is included under this Contract. Contractor will provide updated record drawing of the installation and complete Operations & Maintenance Manuals for the project. A drawing of the equipment installation will show the wiring diagram from the cameras to the Master Distribution Amplifiers to the matrix. Such drawing and the Operations & Maintenance Manuals will be supplied to SIT within two weeks of Project Completion, but prior to final payment. Contractor will keep a copy of such drawing on file to aid in troubleshooting the system.
2. SIT Assistance with Installation. If requested by SIT's Contract Officer, Contractor will allow SIT's technical personnel to assist with the equipment installation, with a view towards improving their knowledge of the system installation and to further their training. SIT understands that personnel selected to assist with the installation should be dedicated for the purpose in order to maximize their training.
3. Design and Pre-Construction.
 - 3.1. Design Documents: Preparation of construction drawings is included in this Contract.

- 3.1.1. SIT's Contract Officer and/or his designees (the "CO team") will provide electronic CAD files of site layouts and building floor plans to Contractor for use in developing camera layouts. Such CAD files will be provided in ".dwg" AutoCAD format. Camera layout drawings will be prepared after the floor plan has been finalized to prevent wasted effort and redesign costs.
 - 3.1.2. Drawings shall include camera floor plan layouts, parking lot camera layouts, system block diagrams, system connection diagrams, rack elevation drawings, surveillance room console and equipment layout drawings, console elevation drawings and other detail drawings as required clarifying the scope of the installation. A complete camera schedule will be developed in spreadsheet format incorporating all cable termination labels and camera specifications. A final "hard-copy" of camera schedule, as well as Microsoft Excel™ spreadsheet will be provided to SIT for its use upon Project Completion.
 - 3.1.3. Contractor will provide electronic files to the CO team for their use. It is assumed that the CO team will provide reprographics of construction documents. Contractor will provide working copies as needed for design consultants and SIT use.
 - 3.2. Design Meetings with the CO team: Contractor will attend four design review meetings at the SIT site to coordinate the surveillance and security system design with other aspects of the installation. It is assumed that correspondence between SIT, Contractor and CO team will be generally carried out via e-mail and courier.
 - 3.3. Coordination with the CO Team: Coordination with the CO team is included in this Contract. Specifically, Contractor will ensure that the surveillance equipment installation is properly coordinated with other aspects of the construction including but not limited to the following:
 - 3.3.1. Provide BTU calculations for the electronic equipment to the mechanical engineer for their use in sizing HVAC equipment.
 - 3.3.2. Provide power calculations, as well as required outlet locations to the electrical engineer for their use in design of the electrical distribution system. It is assumed that all camera power supplies, video matrix, recording equipment, video monitors, access control equipment panels, card readers and maglocks will be provided with emergency power, backed up by a UPS with sufficient battery time.
 - 3.3.3. Provide suggested cable tray routings to the electrical engineer for their use in design of the low-voltage cable management requirements.
 - 3.3.4. Provide conduit sleeve and back box information to electrical engineer for their use in design of low-voltage raceway requirements.
 - 3.3.5. Provide floor plan layouts of the surveillance rooms and coordinate space requirements for surveillance room equipment and consoles, as well as any additional ancillary space required for equipment located remotely from the surveillance room.

- 3.3.6. Review door hardware schedules prepared by the architect to ensure coordination with access control system requirements.
- 3.3.7. Review architectural reflected ceiling plans to coordinate camera placements and ensure proper mounting options.
- 3.3.8. Review architectural theming plans to ensure camera placements are free from visual obstructions.

If the CO team does not have an architect or engineer identified in this subsection 3.3, SIT's Contract Officer may designate another individual to work with Contractor instead.

4. Installation.

- 4.1. Expansion of Existing System: The goods and/or services provided under this Contract will expand an existing Pelco CM9770 Video Matrix Switch (256 x 32) to a (368 x 64). The existing system is installed with a redundant Pelco (CM9700-CC1) Central Processing Unit and Pelco (CM9760-HS) Hot Switch. In order to facilitate expansion both CM9700 CC1s will be upgraded by adding two (2) CM9700-SER Matrix Serial Expansion Cards. The redundant Central Processing Unit and Hot Switch will maintain the system's operational status during this upgrade phase. The expansion will include an additional seven (7) Pelco (CM9760 MDA) Master Distribution Amplifiers ("MDAs"). The expansion of the existing switch and the installation of Endura Network Video Recording equipment will require an EPROM Upgrade and a Reprogramming of the Matrix Switch. Contractor will upgrade exiting switch equipment and reprogramming system files.
- 4.2. New Equipment: Network Video Recording equipment will be provided as manufactured by Pelco (Endura NVR5124-4800 Network Video Recorder) and includes 360 channels of 4CIF Recording at 30 frames per second, seven (7) day retention with Raid 5. A redundant SM5000 System Manager will be installed to provide the Endura system failover capability. Five (5) networked digital viewing stations are included. Two (2) dedicated review stations will be located at the observer console position; one (1) viewing station will be located at the Supervisor's Console. One (1) dedicated review station will be located in the Tribal Gaming Agency Agent's office, and one (1) review station will be provided at a location to be determined. Digital viewing stations consist of Pelco (Endura WS5050) PC Workstations with 19" TFT Color LCD monitors. The Network Video Recording System will be integrated with the existing CM9770 Cross Point Switch. The installation of five (5) (CM9700-MDD-EVS) Endura Matrix Digital Decoders will facilitate instant playback through Observers CCTV's Keyboard.
- 4.3. Equipment Mounting: Matrix and Recording equipment will be mounted in standard 19" equipment racks as manufactured by Middle Atlantic. Each Rack enclosure will be complete with solid rear door, solid top with air circulation fan,

20 amp vertical power strips (Racks supporting Digital Recording and Main Matrix Systems will be complete with two vertical power strips), and blank filler panels to facilitate proper thermal management.

- 4.4. Wiring: Contractor will provide and terminate all “head-end” wiring from Wall Mounted Patch Panel to the MDAs then to be distributed to the Matrix Switch and Network Video Recording. All interconnect wiring will be color coded RG179 “Mini Coax”. All interconnect wiring will be labeled as to identify equipment connected to.
- 4.5. Other Materials: Contractor and SIGC agree that all 110vac, fire proof plywood, backboards, UPS, Conduit & Cable Raceway, and HVAC requirements will be provided by others and such costs are not included in this Contract.
5. Mobilization. Contractor will dispatch a Project Manager to the SIGC site before start of project. The function of the Project Manager will be to provide design coordination with Pelco and all other related parties to insure timely completion. A full crew will be on site no later than one week after final coordination.
6. Equipment: Contractor shall provide the equipment listed on the “Edura Quote” dated 10/11/05 attached hereto and incorporated herein by reference.


