## **RESOLUTION NO. 05- / 2**

### SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands, cultural resources, and treaty resources and rights of the Tribe; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands, cultural resources, and treaty resources of the Tribe; and

WHEREAS, the Cultural Resources Department of Squaxin Island Tribe was created to protect and preserve historical and cultural information, resources, and places; and

WHEREAS, the Tribal Preservation Program's Heritage Preservation Services of the National Park Service has announced the availability of funds for grants under FY 2005 Historic Preservation Fund Grants to Indian Tribes for the purpose of addressing critical cultural and historical preservation issues; and

WHEREAS, Cultural Resources Department has manifested to council the need for Comprehensive Cultural Resources Surveys of the Kennedy Creek and Skookum Inlet Natural Area Preserves, and the Woodard Bay Natural Resources Conservation Area, in conjunction with the Washington State Department of Natural Resources, to identify and preserve archaeological, ethnographic, and historical, and traditional cultural properties within those areas.
