## RESOLUTION NO. 06-84

of the

### SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**

**WHEREAS**, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**


**WHEREAS**, additional clarification is necessary to ensure our ability to institute the National Incident Management System (NIMS) for the purpose of unifying ALL responders' efforts during an emergency/disasters; **and**


**WHEREAS**, the Squaxin Island Tribal Emergency Management System currently uses the Incident Command System (ICS) as referred to in NIMS; supported by the Tribal Incident Command Post (ICP/Emergency Operations Center (EOC), which will be operationally conducted as outlined in the attached document "SQUAXIN ISLAND ICP/EOC" flow chart ; **and**


**NOW THEREFORE BE IT RESOLVED**, that the Squaxin Island Tribe adopts the recommendations presented in the attached document entitled "RECOMMENDATIONS FOR TRIBAL COUNCIL" dated September 12, 2006, in their entirety, which includes the "SQUAXIN ISLAND ICP/EOC" flow chart, as change one to the Comprehensive Emergency Management Plan (CEMP) previously adopted by Resolution 05-107, November 17, 2005.

**RECOMMENDATIONS  
FOR  
TRIBAL COUNCIL  
September 12, 2006**

1. That the configuration outlined in "SQUAXIN ISLAND ICP/EOC" flow chart be approved and adopted as presented.
2. That the following Departments be placed under the listed Sections during an Emergency/Disaster for the purpose of command and control:

3. That the following Departmental Directors be appointed as Section Chiefs for the designated ICP/EOC Positions:

4. That in the event of an Emergency/Disaster and the Emergency Operations Center (EOC) is activated to support the Incident Commander; the EOC Supervisor is dually appointed as the Deputy Incident Commander (DIC).
5. That these Directors, to include the appointed Incident Commanders, Director of Public Safety, and Tribal Emergency and Safety Manager make up the Squaxin Island Tribe Emergency Management/ Homeland Security Committee, which will meet on a regular bases to discuss related issues, review any incidents, provide recommendations, and oversee tribal wide Emergency/Disaster Management and Homeland Security.
