

SQUAXIN ISLAND TRIBE

RESOLUTION NO. 07-<u>34</u> OF THE SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self-government; and

WHEREAS, under the Constitution and the Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**

WHEREAS, the Squaxin Island Tribal Council has an established commitment to and history of working to obtain funding from various sources, including federal and tribal funding, for on- and off-reservation transportation projects of importance to the Tribe and the surrounding community; **and**

WHEREAS, the Squaxin Island Tribal Council is aware that the Squaxin long-range transportation plan (LRTP) for routes on and near the Squaxin Island Reservation and its critical resources is required for federal funding; **and**

WHEREAS, the Squaxin Island Tribal Council is aware that the Squaxin LRTP was initially approved in 1998 with subsequent updates; **and**

WHEREAS, the Squaxin Island Tribal Council is aware that the BIA requires a Squaxin LRTP update when the associated Squaxin route inventory is updated.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby request that the Squaxin long-range transportation plan be updated with the associated route information as listed in Attachment A.
