



# SQUAXIN ISLAND TRIBE

## RESOLUTION NO. 08-20 OF THE SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and**,

**WHEREAS**, under the Constitution and the Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and**,

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and**,

**WHEREAS**, under the Constitution and bylaws of the Tribe, the Squaxin Island Tribal Council has the powers and duties to acquire, manage, and lease Tribal real property and other Tribal Assets; **and**,

**WHEREAS**, the Squaxin Island Tribal Council has the general goal of making the Squaxin Island Reservation an economic, social, cultural, and political land base for the Squaxin Island Tribe; **and**,

**WHEREAS**, the Squaxin Island Tribal Council on behalf of the Tribe has purchased a parcel of property within the Tribe's Land Consolidation area; **and**

**NOW THEREFORE BE IT RESOLVED**, the Squaxin Island Tribal Council hereby requests that the United States, pursuant to 25 CFR 151 and under the authority of the Indian Reorganization Act 48 Stat. 984, accept title to the following described real property in trust for the Squaxin Island Tribe:

Purchased from Marshall:

All that portion of the Southwest quarter (SW  $\frac{1}{4}$ ) of the Southeast quarter (SE  $\frac{1}{4}$ ) of Section eighteen (18), Township nineteen (19) North, Range three (3) West, W.M., particularly described as follows:

COMMENCING at the intersection of the Northerly line right-of-way line of State Route 108 and the East line of the Southwest quarter (SW  $\frac{1}{4}$ ) of the Southeast quarter (SE  $\frac{1}{4}$ ) of said Section eighteen (18); thence Southwesterly along said Northerly right-of-way line, 186 feet, more or less, to the point of intersection with the Westerly line of a tract of land heretofore conveyed to Marjorie Aiken and Robert Aiken, wife and husband in deed recorded February 13, 1946, Auditor's File No. 113599, if the same were extended Southwesterly to said Northerly line of State Route 108, said point being the POINT OF BEGINNING of the tract of land hereby described; thence Southwesterly, along said Northerly right-of-way line, 100 feet; thence Northeasterly, parallel with the Westerly line of said Aiken tract and said Westerly line extended, 475 feet; thence due East, 100 feet, more or less, to the Westerly line of said Aiken

tract, said Westerly line being marked by an old fence; thence Southwesterly, along the Westerly line of said Aiken tract and said Westerly line extended, 475 feet, more or less, to the POINT OF BEGINNING.

ALSO, all that portion of the Southwest quarter (SW ¼) of the Southeast quarter (SE ¼) of Section eighteen (18), Township nineteen (19) North, Range three (3) West, W.M., lying North of State Route 108, particularly described as follows:

COMMENCING at the Northeast corner of said Southwest quarter (SW ¼) of the Southeast quarter (SE ¼); thence North 86°30'47" West along the North line thereof, 267.69 feet; thence South 01°42'39" West, 251.91 feet to the POINT OF BEGINNING of the tract of land hereby described; thence continue South 01°42'39" West, 475.63 feet, more or less, to the Northerly right-of-way line of State Route 108; thence Northeasterly along said Northerly right-of-way line, 17.59 feet, more or less, to the Southwest corner of a tract of land described in instrument recorded under Auditor's File No. 210446; thence North 02°58'26" East, along the West line of said tract, 471.88 feet, more or less, to a point which bears North 86°11'24" East from the point of beginning; thence South 86°11'24" West, 26.89 feet, to the POINT OF BEGINNING.




