

RESOLUTION OF THE SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, The Squaxin Island Tribal Council is the governing body of the Squaxin Island Tribe in accordance with its Constitution and ByLaws, approved by the Secretary of the Interior on July 8, 1965; and,

WHEREAS, In accordance with Article III, Section 1(f) of the approved Constitution and ByLaws, the Tribal Council is authorized to administer the funds under the control of the Tribe and to make available funds for Tribal purposes in accordance with an approved Tribal budget; and,

WHEREAS, The Squaxin Island Tribal Council fees that the following amounts will be needed for Fiscal Year 1971:

WHEREAS, on June 30, 1970, the Tribe had \$559.00 on hand in its Tribal checking account; and,

WHEREAS, The Squaxin Island Treasurer is a bonded Tribal Official, and is authorized to receipt for and to disburse funds in the name of the Tribe.

NOW THEREFORE BE IT RESOLVED By the Squaxin Island Tribal Council that it requests the Superintendent of the Western Washington Agency to approve the Fiscal Year 1971 budget as shown above, and requests that \$ 2900 00 be advanced from the funds now on deposit in the Agency IIM Account to the credit of the Squaxin Island Tribe, to the bonded Tribal Treasurer.
