

# SQUAXIN ISLAND TRIBE

## RESOLUTION NO. 09-36 A

#### of the

### SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; **and** 

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; **and** 

**WHEREAS**, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; **and** 

WHEREAS, the Portland Area Indian Health Service has requested Project Summary Documents that identify projects for the Indian Health Service Maintenance & Improvement Fund through the American Recovery and Reinvestment Act, and

WHEREAS, the Squaxin Island Tribe operates the Northwest Indian Treatment Center and recognizes the need to provide treatment services in a safe and well-maintained facility; and

WHEREAS, Squaxin Island Tribal Council acknowledges that funding provided by the American Recovery and Reinvestment Act (ARRA) is accompanied by an unprecedented level of accountability for project results; and

WHEREAS, The Squaxin Island Tribe agrees to meet ARRA accountability and reporting requirements; and

WHEREAS, The Squaxin Island Tribe agrees to document the deficiencies specifically identified in the Project Summary Document before initiating construction and also agrees to document the correction of the deficiencies specifically identified in the Project Summary Document after completion of the project;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Northwest Indian Treatment Center to prepare, submit, negotiate, execute, and administer with the Indian Health Service, a project for up to \$140,000 through the American Recovery and Reinvestment Act - Indian Health Service -Maintenance & Improvement Fund.

THEREFORE BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chairman, Executive Director, or Deputy Executive Director to be the Tribe's signatory and representative in all future matters requiring Tribal authorization on this particular project; and

THEREFORE BE IT FINALLY RESOLVED, that these authorities shall be for the duration of the project.
