WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by the authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of the tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; and

WHEREAS, The Tribe is a federally-recognized Indian Tribe possessing reserved powers, including the powers of self government; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education, and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and

WHEREAS, the Council recognizes the value of the Canoe Family events as culturally relevant and healthy activities for Tribal members; and

WHEREAS, the Tribal Council allocates funding and other in-kind resources in support of Canoe Family activities, and

WHEREAS, hosting the Canoe Journey of 2012 is a significant financial and time-consuming undertaking for the Tribe and the Council desires to host an inclusive, welcoming and quality event; and

WHEREAS, the Council desires to bring more structure and formality to the Canoe Family meetings and processes and to ensure that allocated funds and other resources are best used for activities that benefit the entire Canoe Family and the Tribe;


