SQUAXIN TRIBAL RESOLUTION
TO EMPLOY ATTORNEY

WHEREAS, the Squaxin Tribe of Indians has pending before the Indian Claims Commission an action against the United States of America, brought under the Indian Claims Commission Act of 1946, and


WHEREAS, the aforesaid litigation has been conducted under a contract with Frederick W. Post which was approved by the Commissioner of Indian Affairs and which was effective April 27, 1967, for a period of five years, and

WHEREAS, the said contract expired on April 26, 1972, and
WHEREAS, the Squaxin Tribe of Indians desires to retain Frederick W. Post as its attorney to complete prosecution of the action under a contract which will provide for his compensation,

NOW THEREFORE, BE IT RESOLVED that the Squaxin Tribe shall retain Frederick W. Post as its attorney to complete the prosecution of its said claim under a contract containing substantially the same terms and conditions as the prior contract contained. The total fee for all lawyers who have worked on the case shall be ten percentum of the amount recovered by the Tribe in the case. The effective date of said contract shall be April 27, 1972, and shall extend from April 27, 1972, through April 26, 1975. Should the work contemplated by this contract not be completed by its expiration date, the contract may be renewed by a request in writing by the party of the second part and a resolution of the Squaxin Tribe for additional two-year periods, subject to the approval of the Secretary of the Interior or his duly authorized representative. The attorney shall advise the Tribe every six months on the progress made on this case.

1 BE IT FURTHER RESOLVED that Florence Sigo and
2 Calvin J. Peters, members of the Squaxin Tribal Council,
3 are appointed to execute the proposed contract.


