

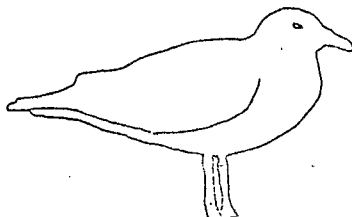

RESOLUTION NO. 76-27

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965, and

WHEREAS, the Squaxin Island Tribal Council, on behalf of the Squaxin Island Tribe, did enter into a Fisheries Enforcement Contract No. 14-20-0500-4539, in the amount of \$93,716.00, and

WHEREAS, the Squaxin Island Tribal Council is desirous of amending the total dollar amount from the original total to \$133,771.72, and

WHEREAS, this amount reflects an approximate \$40,000.00 add-on, as well as line item amendments which more accurately reflect actual expenditures, in line with and up-dating of the Squaxin Island Tribal Accounting procedures, and

WHEREAS, the Squaxin Island Tribal Council, upon the advise of the Chief Enforcement Officer of the Squaxin Island Tribal Police has deleted approximately \$5,000.00 from the requested amount, and

WHEREAS, this amount was to have been utilized for acquisition of supplies, and

WHEREAS, the Western Washington Agency of the Bureau of Indian Affairs has assured the Squaxin Island Tribe that these supplies may be obtained directly from their Enforcement Supplies Budget.

NOW THEREFORE BE IT RESOLVED, the Squaxin Island Tribal Council does hereby authorized the amendment of the Budget of the Fisheries Enforcement Contract No 14-20-0500-4539 to read:
