WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965, and

WHEREAS, the Squaxin Island Tribal Council is desirous of entering into a contract with the Bureau of Indian Affairs for the purpose of funding the Squaxin Island Enrollment/Geneological Research Project, and

WHEREAS, the Squaxin Island Enrollment/Geneological Research Project Proposal has been developed in a form acceptable to the Squaxin Island Tribal Council, and

WHEREAS, said Project is proposed to commence August 15, 1976 and end November 15, 1976, and

WHEREAS, said Project will require funding in the amount of \$6,528.52, and

WHEREAS, the Squaxin Island Tribal Council is desirous of securing funding from the Bureau of Indian Affairs in the full proposed amount.

NOW THEREFORE BE IT RESOLVED, the Squaxin Island Tribal Council does hereby authorize the submission of the Squaxin Island Enrollment/Geneological Research Proposal, commencing August 15, 1976 and Ending November 15, 1976 in the amount of \$6,528.52.






