SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, The Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by the authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of Interior on July 8, 1965

WHEREAS, the Squaxin Island Tribal Council is responsible for managing its tribal fishery

WHEREAS, the Squaxin Island Tribal Council is desirous of submitting its recommendations to the Medicine Creek Treaty Council delegate and Alternate to said Council.

NOW THEREFORE BE IT RESOLVED, the Squaxin Island Tribal Council does hereby appoint Bryan Johnson, Dave Lopeman, Sally Norman, and Bruce Johnson as the Squaxin Island delegates to the Medicine Creek Treaty Commission

BE IT FURTHER RESOLVED, the Squaxin Island Tribal Council does appoint Bryan Johnson as its only representative authorized for election as the Commission and or alternate position to the Medicine Creek Treaty Council


