RESOLUTION NO. 79-13 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and Secretary of the Interior on July 8, 1965, and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the responsibility of providing for the overall health, education and welfare of its Tribal members, and

WHEREAS, the Squaxin Island Tribal Council in keeping with this responsibility is seeking to provide to the youth of the Tribe, a Summer Youth Activities and Enrichment Program, and

WHEREAS, this Youth Enrichment and Activities Program will provide instruction in cultural and contemporary Tribal arts and crafts to approximately 80-90 Tribal youth, and

WHEREAS, the Squaxin Island Tribal Council has the authority under Public Law 93-638 to enter into contracts with the Bureau of Indian Affairs for programs and services benefiting members of the Squaxin Island Tribe, and

WHEREAS, the Squaxin Island Tribal Council designates Mr. Calvin J. Peters, Chairman and/or Mr. Ron Whitener, Business Manager, as Tribal Officials authorized to negotiate, amend and execute this contract with the Bureau of Indian Affairs.


NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby requests the Bureau of Indian Affairs enter into a Public Law 93-638 contract with the Squaxin Island Tribe to implement a Youth Activities and Enrichment Program for 1979.




