RESOLUTION NO. 79-41  
of the  
Squaxin Island Tribe

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the Authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council is desirous of contracting with the Bureau of Indian Affairs for the purpose of providing services to the Squaxin Island Tribe in Fisheries Enhancement and Creek Rehabilitation to realize Tribal Self-Regulation of On and Off-Reservation Treaty Fishing Rights; and

WHEREAS, this program will increase fish productivity through the enhancement of Skookum and Little Creeks; and

WHEREAS, the Squaxin Island Tribal Council is desirous of securing funds from the Bureau of Indian Affairs for the total amount stipulated in the contract proposal accompanying this resolution; and

WHEREAS, the Squaxin Island Tribal Council in exercising Tribal Self-Regulation of On and Off-Reservation Treaty Rights through Public Law No. 93-638, will do so by providing Fisheries Enhancement and Creek Rehabilitation program support.


NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby enter into an agreement with the Bureau of Indian Affairs to contract for Fisheries Enhancement and Creek Rehabilitation program funding in the amount of \$  
and

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council intends for this Fisheries Enhancement and Creek Rehabilitation program contract to commence on October 1, 1979 through September 30, 1980; and


