RESOLUTION NO. 79- 71  
of the  
SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965, and

WHEREAS, the Squaxin Island Tribal Council is charged with the establishment of the Tribal Court; and

WHEREAS, the Squaxin Island Tribal Council has expressed its desire to avail itself of the services of the Northwest Intertribal Court System when said services become available in Resolutions 78-21 and 78-53; and

WHEREAS, by Resolution No. 79-19, the Tribal Council appointed Mary Turgeon, Northwest Intertribal Court System Chief Judge, as Tribal Judge for a period of one year from date, April 18, 1979; and

WHEREAS, the Governing Board of the Northwest Intertribal Court System has further appointed Doreen Schuyler as Associate Judge for that system; and

WHEREAS, the Governing Board of the Northwest Intertribal Court System will also make available to the Tribe other non-staff judges for appeals hearings when necessary, paid judges having been trained by the National American Indian Court Judges Association and presently sitting as Tribal Judges for Indian Tribes in Western Washington;


NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby appoints Mary Turgeon Chief Judge of the Squaxin Island Tribal Court, pursuant to Article I, §5 of the Emergency Court Procedures Ordinance; and

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council, hereby appoints Doreen Schuyler Associate Judge of the Squaxin Island Tribal Court, pursuant to Article 1, §5 of the Emergency Court Procedures Ordinance; and


BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council hereby further appoints as Associate Judges all other, otherwise qualified persons recommended by Chief Judge Mary Turgeon who have been trained by the National American Indian Court Judges Association, who sit as Tribal Judge for other Indian Tribes in the State of Washington, for the sole purpose of sitting as member(s) of a three-person Appeals Court Panel as required by Article II, §7G of the Emergency Court Procedures Ordinance.


CERTIFICATION
