RESOLUTION NO. 80-01 of the SQUAXIN ISLAND GAMBLING COMMISSION


WHEREAS, the Squaxin Island Gambling Commission is the duly authorized entity established by the Squaxin Island Tribal Council to regulate gambling activities on the Squaxin Island Reservation; and

WHEREAS, the Squaxin Island Gambling Commission finds that net revenues from bingo games operated by the Squaxin Island Tribe can be used to significantly contribute to the advancement of the cultural and social welfare of tribal members, Reservation residents, and others closely related to the Squaxin Island Tribe;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Gambling Commission hereby authorizes and licenses the Squaxin Island Tribe, through its Interim Enterprise Manager, Bruce Johnson, to conduct bingo games on the Squaxin Island Reservation, in accordance with the terms of this Resolution, the Squaxin Island Amusement Game and Gambling Ordinance, and other regulations hereafter adopted by the Gambling Commission to regulate such games and activities, conditioned on the payment of all taxes, fees and contractual obligations owing to the Squaxin Island Tribal General Fund by licensee, the Squaxin Island Tribe, as provided for by the Squaxin Island Gambling Commission, for the period of one year.


CERTIFICATION

RESOLUTION NO. 80-1 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965, and

WHEREAS, the Squaxin Island Tribal Council is concerned that adequate protection of persons and property within the jurisdiction of the Tribe is not presently available; and


WHEREAS, the Squaxin Island General Council has instructed the Tribal Council to consider and adopt a Tribal Law and Order Code and Procedural Codes; and

WHEREAS, the Squaxin Island Tribal Council considers the need for such codes to be critical, especially in light of the expected influx of reservation residents in the near future;


NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby promulgates and enacts the attached Squaxin Island Law and Order Code, which defines and sets penalties for criminal offenses committed within the jurisdiction of the Squaxin Island Tribe; and which may be amended by majority vote of the Tribal Council.
