## RESOLUTION NO. 80-16 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by the authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the responsibility of providing for the overall health, education, and welfare of its Tribal members; and

WHEREAS, the Squaxin Island Tribal Council, in keeping with this responsibility, is seeking to provide to the youth of the Tribe a Youth Summer Cultural Arts and Enrichment Program; and

WHEREAS, this Summer Youth Cultural Arts and Enrichment Program will provide instruction in cultural arts to approximately One-Hundred (100) youth; and

WHEREAS, the Squaxin Island Tribal Council has the authority under Public Law 93-638 to enter into contracts with the Bureau of Indian Affairs for programs and services benefiting members of the Squaxin Island Tribe; and

NOW, THEREFORE BE IT RESOLVED that the Squaxin Island Tribal Council hereby requests that the Bureau of Indian Affairs enter into a Public Law 93-638 contract with the Squaxin Island Tribe in the amount of \$ \_\_\_\_\_ to implement a Summer Youth Cultural Arts and Enrichment Program to commence on June 1, 1980 and to terminate on November 30, 1980; and



### CERTIFICATION




