RESOLUTION NO. 80- 19
of the
SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the responsibility of providing for the overall health, education and welfare of its members; and

WHEREAS, the Squaxin Island Tribal Council in keeping with this responsibility is seeking to provide to the youth of the Tribe, a Summer Youth Recreation Program to compliment its existing Summer Youth Cultural and Enrichment program; and

WHEREAS, this Summer Youth Recreation Program will provide a cross-cultural sports program which will enable its youth to better understand the larger non-Indian society by teaching sportsmanship and competition with an atmosphere of cooperation to approximately 100 service population youth; and

WHEREAS, the Squaxin Island Tribal Council has the opportunity to apply for a contract with the Community Services Administration for such services benefitting its members; and

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby authorizes Community Services Administration to enter into a contract with the Squaxin Island Tribe to implement a Summer Youth Recreation Program to commence on June 1, 1980, and terminate on November 30, 1980, in the amount of \$


BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council designate Mr. O'Dean Williamson, Tribal Administrative Director or Mr. Calvin J. Peters, Chairman, as the Tribal officials to further pursue, negotiate, amend and execute this contract with Community Services Administration.


