RESOLUTION No. 80- 3/

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the responsibility of providing for the needs of the community including but not limited to health, education and welfare; and

WHEREAS, the Squaxin Island Tribal Council finds that the tribe has significant needs to improve its management capabilities in the areas of contracting, resource development, community and economic development, and

WHEREAS, the Squaxin Island Tribal Council has determined that the effective utilization of computer management systems and services significantly effects the areas of contracting, resource development, community development, and economic development, and

WHEREAS, funds to assist the tribes in improving their management capabilities are extremely limited, and

WHEREAS, the Squaxin Island Tribal Council finds that significant improvements in this area of need can be effected if resources from more than one agency that is committed to tribal self-determination can be combined to achieve greater impact, and

WHEREAS, the Squaxin Island Tribe is a member tribe of the South Puget Intertribal Planning Agency,

THEREFORE BE IT RESOLVED THAT, the Squaxin Island Tribal Council hereby authorizes the South Puget Intertribal Planning Agency to contract with the Bureau of Indian Affairs, Portland Area for a long term program to improve the Management and Development capabilities of the Squaxin Island government, and






## CERTIFICATION
