RESOLUTION NO. 81-34 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Indian Reservation by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the responsibility of providing for the overall health, education and welfare of its Tribal members; and

WHEREAS, the Squaxin Island Tribal Council, in assessing the educational needs of its members, has identified a major need to provide Adult Basic Education; and

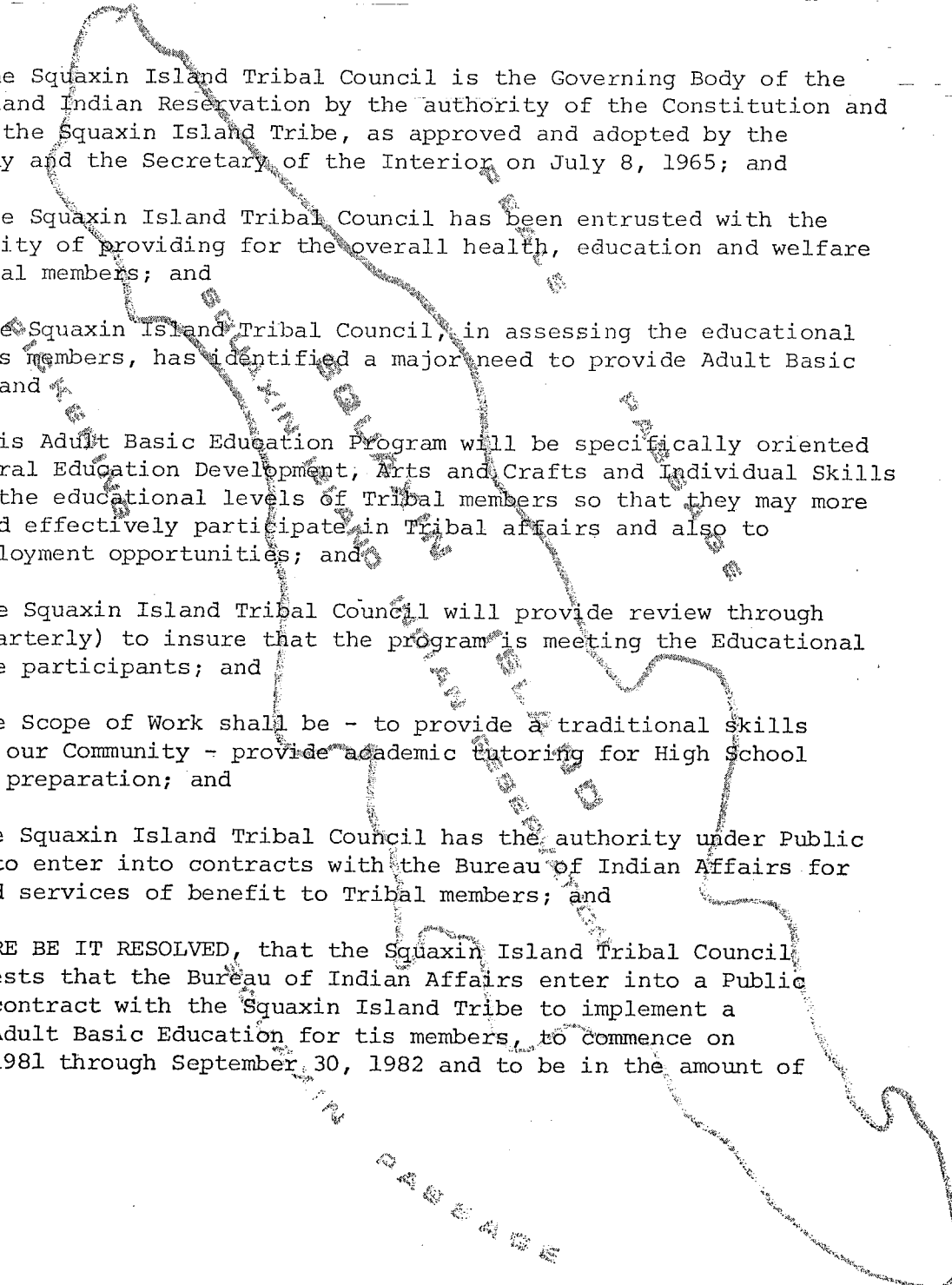
WHEREAS, this Adult Basic Education Program will be specifically oriented toward General Education Development, Arts and Crafts and Individual Skills to upgrade the educational levels of Tribal members so that they may more actively and effectively participate in Tribal affairs and also to enhance employment opportunities; and

WHEREAS, the Squaxin Island Tribal Council will provide review through reports (quarterly) to insure that the program is meeting the Educational needs of the participants; and

WHEREAS, the Scope of Work shall be - to provide a traditional skills program for our Community - provide academic tutoring for High School equivalency preparation; and

WHEREAS, the Squaxin Island Tribal Council has the authority under Public Law 93-638 to enter into contracts with the Bureau of Indian Affairs for programs and services of benefit to Tribal members; and

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby requests that the Bureau of Indian Affairs enter into a Public Law 93-638 contract with the Squaxin Island Tribe to implement a program of Adult Basic Education for tis members, to commence on October 1, 1981 through September 30, 1982 and to be in the amount of \$31,896.00.






BE IT FURTHER RESOLVED, that all individual program elements and expenditures of Adult Education Fund must meet prior Tribal Council approval; and


