ADD NEW SECTION (a) (1) & (2) to Section 1A.05 Suspension

- (a) A duly sworn Squaxin Island Tribal Enforcement Officer is authorized to immediately impound a motor vehicle when he determines
 - (1) That the operator has no valid driver's license (Sec 1A.02)
 - (2) That the operator's license is suspended (Sec 6.21) or revoked (Sec 6.16).

Fines and penalties and impoundment costs must be paid by the owner/operator to retrieve the vehicle. An owner who was not the operator of the vehicle may retrieve it without charge, but the non-owner driver will owe all penalties, fines and impoundment costs.

ADD NEW SECTION

1A.07 Non-Indian Violator's Compact

The Squaxin Island Tribe hereby has the authority to enter into a jurisdictional agreement with Washington State to facilitate suspension of the driver's licenses of non-compliant, non-Indian violators via a process which takes place in the jurisdiction that applies to the violator. i.e. if a non-Indian violator fails to pay a Tribal ticket, the Tribe can ask the Washington State Department of Licensing to suspend the non-compliant violator's drivers license.

ADD NEW CHAPTER 1B

1B.01 Vehicle Registration

It shall be unlawful for any person to operate any vehicle on the Squaxin Island Reservation without a certificate of registration for that vehicle available to the operator and contained within the vehicle.

1B.02 Vehicle License

It shall be unlawful for a person to operate any vehicle over and along a street or highway within the Squaxin Island Reservation without first having obtained and having in full force and effect current and proper vehicle license number plates displayed on that vehicle.

It shall be unlawful for a person to operate any vehicle over and along a street or highway within the Squaxin Island Reservation without first having obtained and having in full force and effect current and proper vehicle license number plates displayed on that vehicle.
