RESOLUTION NO. 82-28

of the

SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council is desirous of contracting wont the Bureau of Indian Affairs for the purpose of providing services to the Squaxin Island Tribe in Fisheries Management, Fisheries Law Enforcement and Enrollment program to realize tribal self-regulation of on and off reservation treaty fishing rights; and

WHEREAS, said contract is proposed to commence Octover 1, 1982, and terminate on September 30, 1983; and

WHEREAS, the Squaxin Island Tribal Council is desirous of securing funds from the Bureau of Indian Affairs for \$337,000 plus indirect cost as stipulated in the contract proposal accompanying this resolution.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council in exercising tribal self-regulation of on and off reservation treaty fishing rights through aforementioned Public Law No. 93-638 contract, will do so by providing Fisheries Management, Enforcement and Enrollment program support.

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council has authorized the following representatives to negotiate and sign all the terms of and for the duration of the contract; David W. Whitener, Chairman, Evelyn Allen, Vice Chairman, and David Lopeman, Secretary.
