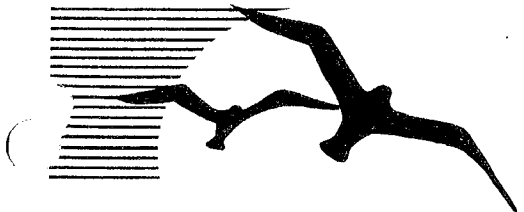

Dear Mr. Whitener,

I conduct business with your tribe through my employment with Central Liquor Company of Oklahoma and Redwood Distributors of Arcata, California.

As you know, Washington State would like to stop your sales of liquor. While the state has not been successful in its efforts against your tribe, it is possible that at some point in time the state may attempt to stop your liquor supply by preventing me from doing business with you.


Although I possess an Oklahoma Liquor Agent license, I do not possess a similar Washington State license, nor do I have any intention of obtaining one.

Perhaps I would be in a better position to continue doing my wholesale business with your tribe if I were to obtain a Federal Indian Trader's License. This license is issued by the Bureau in Everett through Frank Perot's Realty Office. Such a license would give me no special privileges, but merely state that I am of good character and licensed by an agency of the Federal Government (BIA) to do business with you.

I have completed the necessary application and now need a resolution from your Tribal Council requesting the BIA Realty Office to issue me a Trader's License. I would be most grateful if you would consider such a resolution.

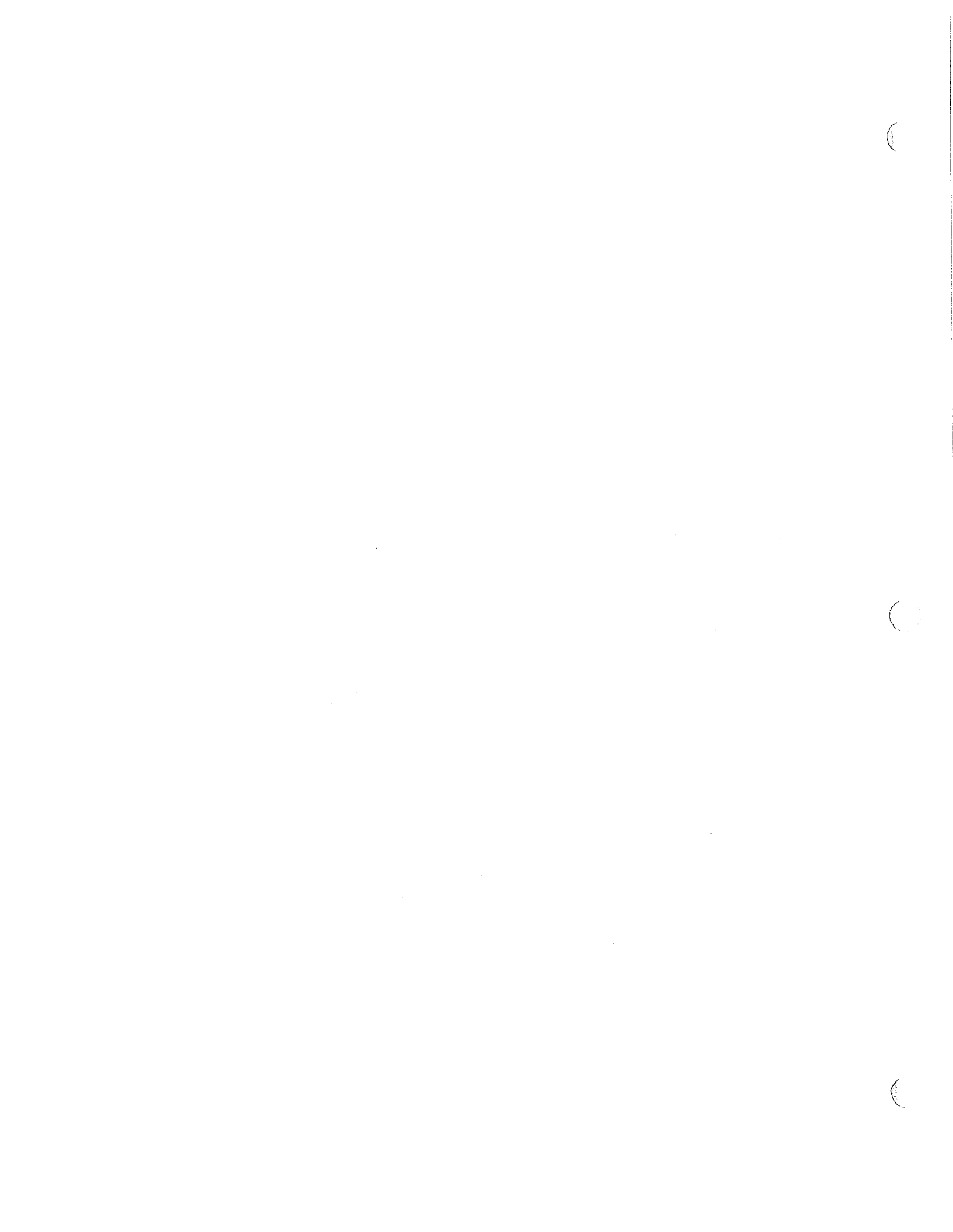
If you so desire, I could answer any questions you might have or request such a resolution in person from your Council.
