

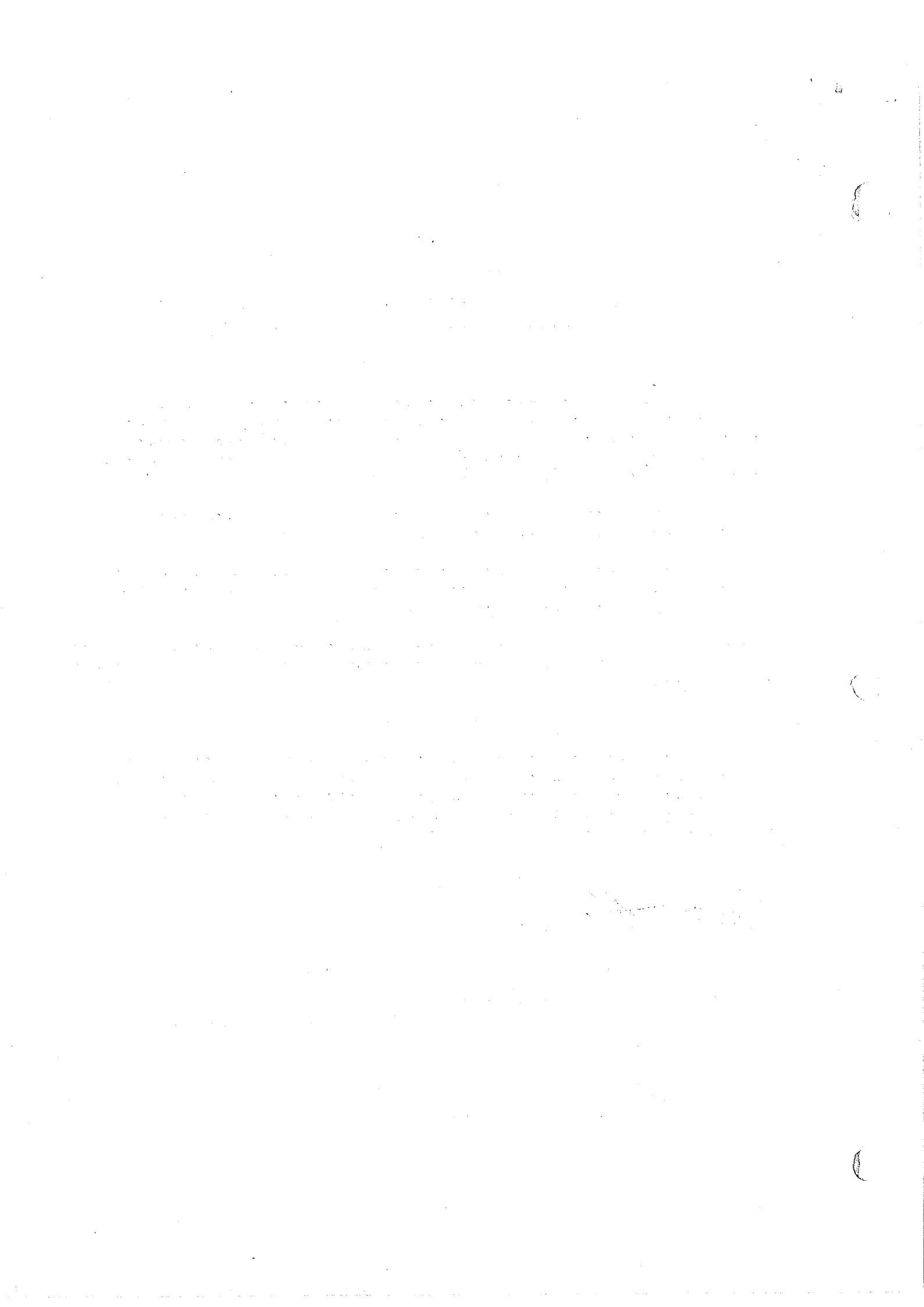

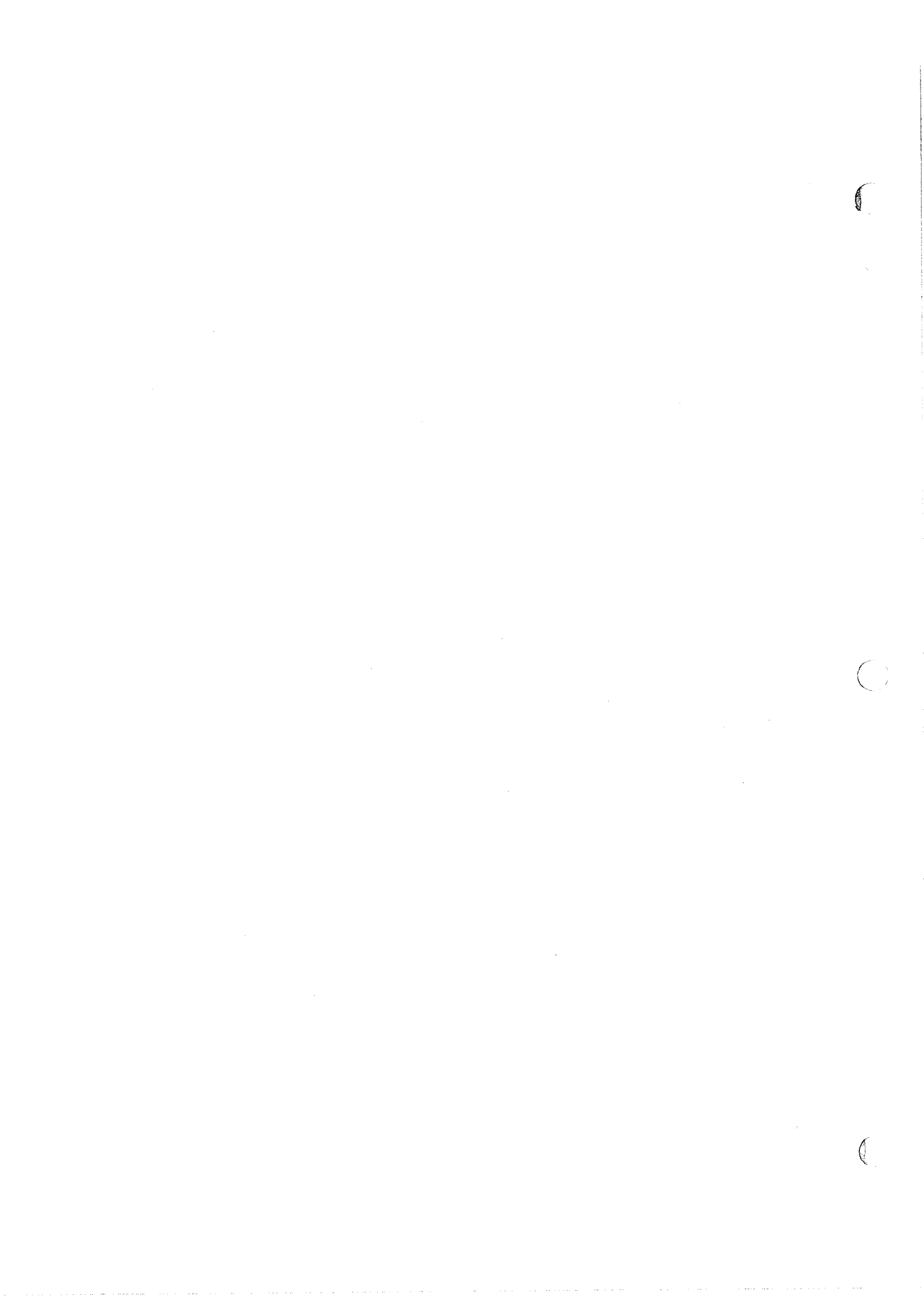

FISHING ORDINANCE CHANGES

Insert #1 (Page 5, #1)

(1) The Fish Committee shall have seven members, all of whom shall be appointed by the Tribal Council, fo a trhee-year term to begin on the first day of the calendar year. Terms will be on an alternating basis with appointment of two or three persons per year. Any member may be appointed to serve for more than one term.

Insert #2 (Page 11, Para. A, Item #3)

(3) "when necessary" (at end of sentence)

Deletion #1 (Page 16, end of #1 under Assistant Identification)

Deletion #2 (Page 18, Delete Item #2)

Insert #3 (Page 19) Deletions and add at end:

The information required for use on the prescribed fish ticket will be embossed on the tribal ID card.

Deletion #4 (Page 23, Item A under Gear ID Requirements)

Delete "of the bow"

Deletion #5 (Page 23, #2) "two and one half (2 1/2) fishing days"
and ADD "48^{FISHING} hours"
