RESOLUTION NO. 84-29
of the
SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the responsibility of providing for the overall health, education and welfare of its Tribal members; and

WHEREAS, the Tribal community has identified in its 1981/84 Specific Health Plan the lack of adequate on-site health services for preventing and treating medical problems of Tribal members; and

WHEREAS, the Tribe has prioritized the provision of accessible on-site preventive, educational, screening and medical services to the Squaxin Island residents of the area as the number one development strategy; and

WHEREAS, the Tribe will implement a two and a half day direct care site, staffed by a Family Nurse Practitioner or physician who will provide professional medical care in accordance with Standard Medical Practices and within the limits of the available funding and community resources; and

WHEREAS, the joint-use and administration of funds for the Family Nurse Practitioner or physician will be accomplished with coordination of program efforts with the Skokomish Tribe; and

WHEREAS, the Skokomish and Squaxin Island Tribe will contribute fifty percent of the funds for the FNP/or physician and mutually supervise and administer the position under the auspice of a clinic board of Tribal members and staff from both Tribes; and

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby authorizes the submission of this application for Health Equity Care Funds for primary care and health education services; and

BE IT FURTHER RESOLVED, the Squaxin Island Tribal Council approves the use of the Squaxin Island Health Equity Care funds for a Family Health Clinic for the Squaxin Island Tribe; and

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council also approves the use of the Squaxin Island Health Equity Care Funds for Community Home Services, Dental Lab, and the Administrative Services thereof; and

BE IT FURTHER RESOLVED, that the anticipated contract period for this contract with IHS will start October 1, 1984 and end September 30, 1985; and hereby




C E R T I F I C A T I O N
