WEST 81 HIGHWAY 108 SHELTON, WASHINGTON 98584 (206) 426-9781 RESOLUTION NO. 88-54 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Inteior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted to provide for the social, health and economic well-being of the Squaxin Island Tribal Citizens; and

WHEREAS, Indian communities across the nation have the worst health, education, housing, and economic conditions of any culture in today's society; and

WHEREAS, the State-Tribal relations are very important to the long term welfare of the Indian people, as well as the general community associated with the 26 Indian tribes in Washington State; and

WHEREAS, the State-Tribal Polciy has not proved to be effective in the past in improving the cooperation and coordination of programs and services that impact Indian people, as well as provide the positive conditons to enhance the economic base of Indian reservations; and

WHEREAS, the 26 Tribes of Washington State have consistently been attempting to improve these conditions and policy(s) to develop a sound and stable foundation that will be the basis of a progressive and prosperous future for Indian and non-Indian people alike; and

WHEREAS, the State of Washington has expessed an encouraging willingness to resolve these needs by improving the policies, laws, programs, and services that affect these conditions; and

WHEREAS, a number of tribes have been meeting with Governor Booth Garndner and his department directors to establish positive policies, that will dramatically reduce the conflict and negative attitudes that have been obstacles to genuine improvements of the welfare of Indian communities and effective government to government relationships; and

WHEREAS, these tribes and Governor have recommended that a Task Force be established to devlop the language, conditions, and criteria necessary to be incorporated into these policies, agreements, and potential laws and regulations conducive to this mission; and Page 2 - Resolution No. 88-54

WHEREAS, the Squaxin Island Tribe is in support of the Task Force and encourages the continued efforts to initiate an effective policy for State-Indian relationships.

**NOW THEREFORE BE IT RESOLVED,** that the Squaxin Island Tribe does hereby endorse this mission; and

**BE IT FURTHER RESOLVED,** that the Squaxin Islan Tribe acknowledges the following members as serving on the Task Force to develop the proposals to be considered by the State and 26 tribes of Washington State.

**BE IT FURTHER RESOLVED,** that inablity to send a delegate does not preclude or restrict participation in the process at anytime by any of the tribes not identified above.

**BE IT FINALLY RESOLVED,** that all final drafts of proposed agreements and policies developed by the Task Force will be reviewed by each Tribal Council of the 26 tribes in Washington State for final modification and/or formal approval.

## CERTIFICATION

The Squaxin Island Tribal Council does hereby certify taht the foregoing Resolution was adopted at a regular meeting of the Squaxin Island Tribal Council held on this 20th day of October, 1988, at which time a quorum was present and passed by a vote of 4 for 0 against, and 0 abstentions.
