**RESOLUTION NO. 89- 55
of the
SQUAXIN ISLAND TRIBAL COUNCIL**

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribe conducted a special summer youth program during the year 1987; and

WHEREAS, the youth workers with the help of the Prevention Program worker, Rhonda Foster, were totally responsible for the Summer Program and the planned ceremony in September. The Summer workers hired were: Angel Van Brunt, Becky Norman, Chauncey Blueback, Christine Lopeman, Eric Johnson, Jason Fletcher and Kim Peters, and

WHEREAS, the Summer Workers researched a ceremony called "sqwe'gwe" (Potlatch) and the children conducted the ceremony for the elders. WHEREAS, the Squaxin Island Tribal Council acknowledged and supported the ceremony and the silk screen design representing Squaxin Island families.




