RESOLUTION NO. 91-26 of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, The Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution and By-laws of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, and general welfare of the Squaxin Island Tribal Reservation residents; and,

WHEREAS, The Squaxin Island Tribal Council in the interest of improving the living conditions and quality of life for members of the Squaxin Island Tribe joined with the Nisqually Tribe, the Skokomish Tribe, and the Shoalwater Bay Tribe to form the South Puget Sound Intertribal Housing Authority; and,

WHEREAS, the purpose of the South Puget Sound Intertribal Housing Authority was to unite the Indian populations of member Tribes to contract with the Department of Housing and Urban Development to provide safe and adequate housing, on behalf of the member Tribes, so that members of those Tribes or other Indian persons who would ultimately reside within those homes; and,

WHEREAS, representatives of the South Puget Sound Intertribal Housing Authority seem to have lost sight of their delegated responsibility of providing safe and adequate housing for Indian people so that they, the residents of Tribal Housing, might enjoy an improved quality of life, a sense of community, and an overall sense of security, by employing a policy of harassment, threats, and intimidation in their dealings with homeowners on the Squaxin Island Indian Reservation - Klah-Che-Min Village.

NOW THEREFORE BE IT RESOLVED the Squaxin Island Tribal Council does hereby decree that the South Puget Sound Intertribal Housing Authority shall immediately cease and desist all such activity, within the boundaries of the Squaxin Island Indian Reservation, that may be construed to be harassment, threatening, intimidating, or otherwise punitive in their dealings with the residents of the Squaxin Island Housing area known as Klah-Che-Min Village



WHEREAS, representatives of the South Puget Sound Intertribal Housing Authority seem to have lost sight of their delegated responsibility of providing safe and adequate housing for Indian people so that they, the residents of Tribal Housing, might enjoy an improved quality of life, a sense of community, and an overall sense of security, by employing a policy of harassment, threats, and intimidation in their dealings with homeowners on the Squaxin Island Indian Reservation - Klah-Che-Min Village.

NOW THEREFORE BE IT RESOLVED the Squaxin Island Tribal Council does hereby decree that the South Puget Sound Intertribal Housing Authority shall immediately cease and desist all such activity, within the boundaries of the Squaxin Island Indian Reservation, that may be construed to be harassment, threatening, intimidating, or otherwise punitive in their dealings with the residents of the Squaxin Island Housing area known as Klah-Che-Min Village
