WHEREAS, the Indian Health Service will build sewage treatment facilities for the 21 units under HUD WA-52-17.

WHEREAS, it has become necessary to amend the Project Summary and Memorandum of Agreement to separate the water improvement facilities and construct community water system improvements; and


WHEREAS, in addition the IHS wishes to construct additional sewage treatment facilities for 10 new HUD units under HUD WA-52-21.


