NOW THEREFORE BE IT RESOLVED, the Squaxin Island Tribal Council does hereby appoint John Brady Whitener as Squaxin Island Delegate to the Northwest Intertribal Court System.



WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the Authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, under the Constitution and By-laws of the Tribe the Squaxin Island Tribal Council is charged with the duty of protecting the health, security and general welfare of the Squaxin Island Tribal Reservation citizens; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted by the Squaxin Island Tribal members to develop the economic potential of various Tribal enterprises in order to better provide for the continuation and expansion of basic Tribal services; and

WHEREAS, the Squaxin Island Tribal Council has established a tribal business organization, Island Enterprises, to develop the economic potential of various Tribal enterprises in order to better provide for the continuation and expansion of basic Tribal services to its members; and

WHEREAS, the Squaxin Island Tribal Council wishes to investigate opportunities for the Tribe to establish a gambling enterprise on the Squaxin Island Reservation.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby authorize David Whitener, Jr., Island Enterprises Director to pursue and enter into a contract with the State of Washington under the conditions set forth in the Indian Gaming Regulatory Act of the United States.
