## RESOLUTION NO. - 91-84 OF THE SQUAXIN ISLAND TRIBAL COUNCIL

**WHEREAS**, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the Authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

**WHEREAS**, under the Constitution and By-laws of the Tribe the Squaxin Island Tribal Council is charged with the duty of protecting the health, security and general welfare of the Squaxin Island Tribal Reservation citizens; and


**WHEREAS**, the Squaxin Island Tribe has seven mature contracts with the Bureau of Indian Affairs and;

**WHEREAS**, the Squaxin Island Tribe has the financial stability and financial management capability as evidenced by having no significant or material audit exceptions for the last seven fiscal years.

**NOW THEREFORE BE IT RESOLVED**, the Squaxin Island Tribe does hereby request to participate in the Tribal Self-Governance project as specified in Title III - the Tribal Self-Governance project contained in Public Law 100-472 of September 15, 1988.

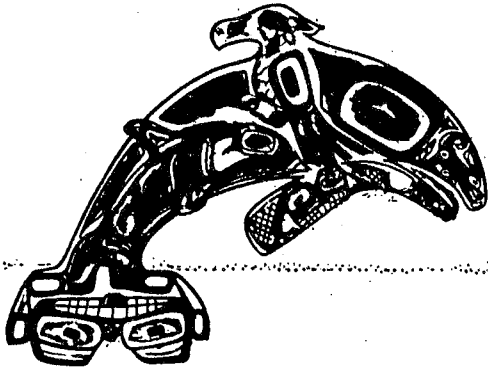
### CERTIFICATION
