RESOLUTION NO. 93- 32
of the
SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the governing body of the Squaxin Island Tribe of Indians by the authority of the constitution and by-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and


WHEREAS, the Squaxin Island Tribal Council has the authority to promulgate laws and ordinances for the protection and well-being of the Tribe and it's members, and

WHEREAS, the Squaxin Island Tribal Council finds it necessary and appropriate to adopt a bail schedule for civil traffic infractions and to amend the Traffic Code to reflect this and finds that the amendments will be beneficial to the safety and welfare of the Squaxin Island Tribal Community;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby amends the Squaxin Island Tribal Traffic Code as set forth in the attached draft, effective the 22nd day of April, 1993.


C E R T I F I C A T I O N


