WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the authority of the Constitution and By-laws of the Squaxin Island Tribe as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted to perform Governmental functions efficiently and strives to obtain committee goals and priorities; and

WHEREAS, to date there exist no advisory committee to:

- incorporate committee priorities into program budgets,.
- review draft budget ordinance and tax ordinance,
- propose and review departmental budgets and reporting procedures.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby approve that an interim Budget Committee be formed and shall serve until replaced by the Tribal Council or the adoption of a Budget Ordinance establishing a permanent Budget Committee.

BE IT FURTHER RESOLVED, that the interim Budget Committee shall consist of Arnold Cooper, who shall be Chairman of the committee, B.J. Whitener, Mike Peters, Alene Whitener and Sound Sou

BE IT FURTHER RESOLVED, this committee shall be under the direction of the Tribal Council Treasurer, Arnold Cooper, and shall give priority to the review and passage of a Budget Ordinance by the Tribal Council.



WHEREAS, the Tribal Council appointed a Personnel Committee to serve as an advisory board on matters involving personnel issues for the Tribe.


