


## **SQUAXIN ISLAND TRIBE**



WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe of Indians by the Authority of the Constitution and By-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has been entrusted to provide for the social, health, and economic well being of its members; and

WHEREAS, the improvement of housing conditions for Tribal members has long been a priority of the Squaxin Island Council; and

WHEREAS, the Squaxin Island Tribal Council conducted a housing inventory including Indians living within the designated Squaxin Island Service area in S.E. Mason County and S.W. Thurston County.

WHEREAS, the Squaxin Island Tribal Council will include all Squaxin Island Tribal Members homes on or off Reservation, living in or outside of the Service area if not served by another Tribe.

NOW, THEREFORE BE IT RESOLVED the Squaxin Island Tribal Council does hereby certify the 1993 Squaxin Island housing Inventory as being an accurate survey of housing characteristics of the Squaxin Island Tribe.

BE IT FURTHER RESOLVED, the Squaxin Island Tribal Council reserves the right to make corrections, additions, and/or deletions as more complete assessments are made on each house.
