

## **SQUAXIN ISLAND TRIBE**

## RESOLUTION NO. 94-<u>45</u> of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe by the authority of the Constitution and By-Laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and,

WHEREAS, under the Constitution and By-Laws of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, and general welfare of the Squaxin Island Tribal Reservation residents; and,

WHEREAS, the Squaxin Island Tribal Council, on behalf of the community, places the highest priority on re-establishing a self-sufficient and self-contained lifestyle which is the traditional way of the people; and,

WHEREAS, the Squaxin Island Tribal Council, has become aware that the Washington State Department of Community Development has announced its intent to fund planning for high priority economic development projects; and,

WHEREAS, the Squaxin Island Tribal Council has identified shellfish harvesting and enhancement as both a traditional activity and a high priority economic development activity; and,

WHEREAS, the Squaxin Island Tribal Council submitted an application on February 1, 1994 to the Washington State Department of Community Development to develop a shellfish hatchery under the President's Economic Adjustment Initiative and that application was forwarded to the Rural Development Administration for possible funding; and,

WHEREAS, the Squaxin Island Tribal Council recognizes that the primary funding mechanism used by the Rural Development Administration is low-interest loans; and,

WHEREAS, the Squaxin Island Tribal Council requires additional economic and technical information regarding the proposed hatchery facility before considering an application to the Rural Development Administration to fund the project.

## **RESOLUTION - Page 2**

THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council on behalf of the Squaxin Island Tribe does hereby approve submission of an application to Washington State Department of Community Development requesting the Department to fund a feasibility study for developing tribal shellfish hatchery and/or nursery facilities at selected sites in the Southern Puget Sound, and including in the study, development of a business plan for the facilities and an evaluation of the market demand for shellfish seed and harvestable shellfish.

BE IT FURTHER RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chairman or the Tribal Executive Director to be the Tribe's representative in all future matters requiring Tribal authorization on this particular project; and

BE IT FURTHER RESOLVED that these authorities shall be for the duration of this project.

## CERTIFICATION

The Squaxin Island Tribal Council does hereby certify that the foregoing Resolution was adopted at the regular meeting of the Squaxin Island Tribal Council, held on this 14 day of April 1994, at which time a quorum was present and was passed by a vote of  $\Im$  for and  $\mathcal{O}$ against with / abstentions.
