RESOLUTION NO. <u>95.54</u> of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the governing body of the Squaxin Island Tribe of Indians by the authority of the constitution and by-laws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and

WHEREAS, the Squaxin Island Tribal Council has the authority to promulgate laws and ordinances for the protection and well-being of the Tribe and it's members, and

WHEREAS, the Squaxin Island Tribal Council finds it necessary and appropriate to authorize by resolution to add to the Law and Order Code, Section 2.21.050, Opening or consuming liquor in Public Place, and 2.21.060, Intoxication in a Public Place and finds that the above additions will be beneficial to the safety and welfare of the Squaxin Island Tribal Community;

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council hereby amends the Squaxin Island Tribal Law and Order Code as set forth in the attached draft, effective the 22nd day of June, 1995.

## Chapter 2.21 Liquor

#### 2.21.010 Reference

In addition to the offenses set forth in this Section, activities related to liquor within the jurisdiction of the Squaxin Island Tribe shall be controlled pursuant to the Squaxin Island Liquor Code.

- 2.21.020 Illegal Sale, Purchase, Possession of Liquor: Illegal Transfer or Use of I.D.
  - (1) No person shall:
    - (a) Sell or offer for sale by the drink or bottle, or keep or possess with intent to sell any liquor, except as authorized by the Squaxin Island Liquor Code of January 27, 1981;
    - (b) Purchase liquor from any person other than at a duly authorized tribal liquor store;
    - (c) Transfer an identification of age to a minor for the purpose of permitting such minor to obtain liquor; provided that corroborative testimony of a witness other than a minor shall be a requirement of conviction; or
    - (d) Attempt to purchase liquor through the use of false or altered identification which falsely purports to show the individual to be over the age of 21 years.
  - (2) Any violation of this Section shall be a gross misdemeanor.

# 2.21.030 Minor in Possession of Liquor

- (1) No person under twenty-one (21) years of age shall purchase, possess, obtain, or sell any liquor.
- (2) Any violation of this section is a misdemeanor.

## 2.21.040 Minor Consuming Liquor

- (1) No person under twenty-one (21) years of age shall consume any liquor.
- (2) "Consume" means the act of consuming liquor, the condition of having consumed liquor, and the condition of being under the influence of liquor.

(3) Any violation of this section is a misdemeanor.

2.21.050 Opening or Consuming Liquor in Public Place

- (1) No person shall open the package containing liquor or consume liquor in a public place.
- (2) Any violation of this section is a misdemeanor.

## 2.21.060 Intoxication in a Public Place

- (1) No person who is intoxicated shall be or remain in any public place.
- (2) Any violation of this section is a misdemeanor.

PUBLIC PLACE IS DEFINED AS: Any place to which the general public has unrestricted access or any property owned by the Squaxin Island Tribe, which includes being in the public view, but not including inside of private dwellings or buildings.
