

SQUAXIN ISLAND TRIBE

RESOLUTION NO. 98-<u>//</u>S of the SQUAXIN ISLAND TRIBAL COUNCIL

WHEREAS, the Squaxin Island Tribal Council is the Governing Body of the Squaxin Island Tribe, its members, its lands, its enterprises and its agencies by authority of the Constitution and Bylaws of the Squaxin Island Tribe, as approved and adopted by the General Body and the Secretary of the Interior on July 8, 1965; and,

WHEREAS, under the Constitution, Bylaws and inherent sovereignty of the Tribe, the Squaxin Island Tribal Council is charged with the duty of protecting the health, security, education and general welfare of tribal members, and with protecting and managing the lands and treaty resources and rights of the Tribe; and,

WHEREAS, the Squaxin Island Tribal Council has been entrusted with the creation of ordinances and resolutions in order to fulfill their duty of protecting the health, security, education and general welfare of tribal members, and of protecting and managing the lands and treaty resources of the Tribe; and,

WHEREAS, the Bureau of Indian Affairs maintains the official Road and Bridge Inventory for Indian Reservation Roads (IRR); and,

WHEREAS, the Squaxin Island Tribal Council requests revisions to the IRR inventory as shown on the attached Summary Sheet; and,

WHEREAS, each road/street on Attachment "A" is defined by a completed BIA form 5704; and,

WHEREAS, each road/street on Attachment "A" is further defined by a strip map that has a north arrow and indicates each section of the proposed new route; and,

WHEREAS, each strip map provides the necessary information to locate the route to other principle topographic and cultural features such a streams/rivers, railroads, airports/airstrips, adjacent or nearby BIA and non-BIA routes, political subdivision boundaries, or cadastral lines.

NOW THEREFORE BE IT RESOLVED, that the Squaxin Island Tribal Council does hereby request that the roads/streets and associated mileage, as shown on Attachment "A", be added to the IRR Road and Bridge inventory.

NOW THEREFORE BE IT FURTHER RESOLVED, that the routes indicated on Attachment "A" shall be public routes.

NOW THEREFORE BE IT FINALLY RESOLVED, that the Squaxin Island Tribal Council does hereby authorize the Tribal Chairman, the Executive Director, or the Deputy Executive Director to be the Tribe's signatory and representative in granting appropriate Rights-of-Way easements to the BIA for routes identified on Attachment "A".
